## ENGINEERING TECHNICIAN (ENG TECH) THROUGH BINDT

The Engineering Council Working Group (ECWG), which is a sub-committee of the BINDT's Membership Qualification and Education Committee (MQ&E), has recently conducted a matching exercise between the requirements of the Engineering Council's UK Specification for Engineering Technicians (Eng Tech) and the requirements of both Graduate Membership and PCN Level 2 Certificate holders.

The results of this matching exercise, which has now been approved by the Engineering Council, are as follows:

**If a candidate holds, as a minimum, Graduate Membership of BINDT and a PCN Level 2 certificate, the individual is now eligible for direct entry (without interview) to register as an Engineering Technician (Eng Tech) with the Engineering Council by application through BINDT.**

### Your Role in Industry Today?

Within the NDT industry, PCN Level 2s who are now eligible for Engineering Technician status play a crucial role in the development, production and maintenance of all kinds of product, plant and processes. Indeed, the critical decisions you are called on to make can have significant impact on business bottom line. Supervising the work of others is often one of your responsibilities.

To register as an Engineering Technician you must be, or become, a Graduate Member of BINDT.

**For Graduate Member (GInstNDT) you need to satisfy the following requirements:**

1. Any person who has been actively engaged in the practice of NDT or related technology for at least 3 years may be elected to the grade of Graduate.
2. A candidate applying for entry or transfer to this grade shall meet the following requirements:
  - i) Possess a PCN Level 2 or other equivalent National or International Certificate, **and**
  - ii) Have a minimum of 3 years' combined training and experience in the profession of NDT or related technology.

**Cost of application for Graduate Member is £15.00 and an Annual Fee of £70.00.**

As a Graduate Member, please fill in the application for Eng Tech and send a copy of your PCN Level 2 Certification. This will automatically make you eligible for Eng Tech.

**The normal cost of application for Eng Tech Registration is £50.00 and an Annual Fee of £15.80.**

**For a limited period BINDT, as an introductory offer, is cutting the total cost of application for Eng Tech Registration to £15.00.**
